Price allows for 1 x cut out for a drop-in style sink & 1x drop-in style hotplate. Unless specified, no allowance has been made for under mounted sinks, aprons, gable ends or splash backs. All prices are fixed for a period of thirty (30) days after which variations may occur. Unless a 30 Day credit account has been set-up and approved by GMG Stone Accounts Department, a deposit of 5% is required along with first payment of 45% for the progress of the scope of Works. Any call backs will incur \$200.00+GST per hour charge. Pricing does not include the mechanical fixing of any sinks, hotplates, basin or taps. GMG Stone does not fit drop, vessel or semi recess type sinks or basins. GMG Stone recommends the client use the service of a licensed plumber. It is the client/customers responsibility to notify GMG in writing at time of quote any onsite situations that may cause delays or extra time/expense to complete the job (onsite inductions, adverse parking or access etc). All damage to bench tops post installation which cannot be deemed the responsibility of GMG Stone will not be covered by GMG Stone's general installation warranty and all costs associated with rectification or replacement will be at the responsibility of the Client/Customers.
